WE HEREBY ENGAGE WITH YOU THAT DRAFTS DRAWN AND PRESENTED BY YOU IN ACCORDANCE WITH THE TERMS OF THIS CREDIT WILL BE DULY HONORED BY US IF PRESENTED TO US AT OUR LETTER OF CREDIT SECTION AT COMERICA BANK, INTERNATIONAL TRADE SERVICES, MC 3341, 411 WEST LAFAYETTE, DETROIT, MI 48226 BY MAY 18, 2011, OR PRIOR TO ANY SUBSEQUENT EXPIRATION AS PROVIDED HEREIN.

DRAFTS DRAWN HEREUNDER MUST BE MARKED "DRAWN UNDER COMERICA BANK LETTER OF CREDIT NO. 646645-04 DATED JUNE 2, 2010" AND ACCOMPANIED BY A STATEMENT PURPORTEDLY SIGNED BY AN AUTHORIZED REPRESENTATIVE OF THE DEPARTMENT READING AS FOLLOWS:

"I CERTIFY THE PENNSYLVANIA DEPARTMENT OF ENVIRONMENTAL PROTECTION IS MAKING THIS DRAWING PURSUANT TO THE TERMS OF A CERTAIN COLLATERAL BOND AGREEMENT BETWEEN THE ENVIRITE OF PENNSYLVANIA, INC. AND THE DEPARTMENT AND THAT THE DEPARTMENT IS ENTITLED TO THE AMOUNT OF THIS DRAW."

THE ORIGINAL LETTER OF CREDIT AND ALL AMENDMENTS, IF ANY, MUST BE PRESENTED AT THE TIME OF ANY DRAWINGS HEREUNDER FOR OUR ENDORSEMENT.

IT IS A CONDITION OF THIS LETTER OF CREDIT THAT IT SHALL BE AUTOMATICALLY EXTENDED FOR ADDITIONAL TERMS OF ONE (1) YEAR FROM THE PRESENT OR EACH FUTURE EXPIRATION DATE UNLESS WE GIVE YOU AND ENVIRITE OF PENNSYLVANIA, INC. AT LEAST ONE HUNDRED TWENTY (120) DAYS BEFORE SAID EXPIRATION DATE WRITTEN NOTICE BY A NATIONALLY RECOGNIZED OVERNIGHT COURIER SERVICE OR HAND DELIVERY, THAT WE ELECT TO TERMINATE THIS CREDIT AT THE END OF ITS THEN CURRENT TERM.

IN THE EVENT WE GIVE NOTICE OF OUR ELECTION TO TERMINATE THIS LETTER OF CREDIT AND ENVIRITE OF PENNSYLVANIA, INC. FAILS TO REPLACE THIS LETTER OF CREDIT WITH OTHER FINANCIAL GUARANTEES ACCEPTABLE TO THE DEPARTMENT, YOU MAY DRAW ON THIS LETTER OF CREDIT, UP TO THE AGGREGATE, LESS ANY PRIOR DRAFTS PRESENTED BY THE DEPARTMENT AND PAID BY US, NOT SOONER THEN THIRTY (30) DAYS AFTER THE DATE OF SUCH NOTICE BY PRESENTATION OF A DRAFT MARKED "DRAWN UNDER COMERICA BANK LETTER OF CREDIT NUMBER 646645-04 DATED JUNE 2, 2010" ACCOMPANIED BY A STATEMENT PURPORTEDLY SIGNED BY AN AUTHORIZED REPRESENTATIVE OF THE DEPARTMENT READING AS FOLLOWS:

THE PENNSYLVANIA DEPARTMENT OF ENVIRONMENTAL PROTECTION IS MAKING THIS DRAWING BECAUSE ENVIRITE OF PENNSYLVANIA, INC. HAS FAILED TO REPLACE THIS LETTER OF CREDIT WITH OTHER FINANCIAL GUARANTEES ACCEPTABLE TO THE DEPARTMENT."

IRREVOCABLE LETTER OF CREDIT NO. 646645-04

THIS LETTER OF CREDIT SETS FORTH OUR ENTIRE UNDERTAKING. OUR UNDERTAKING SHALL NOT IN ANY WAY BE MODIFIED, AMENDED, AMPLIFIED OR LIMITED BY REFERENCE TO ANY DOCUMENT, BOND, PERMIT, INSTRUMENT OR AGREEMENT REFERRED TO IN THIS LETTER OF CREDIT, OR IN WHICH THIS LETTER OF CREDIT IS REFERRED TO, OR TO WHICH THIS LETTER OF CREDIT RELATES, AND ANY SUCH REFERENCE SHALL NOT BE DEEMED TO INCORPORATE HEREIN BY REFERENCE IN THIS LETTER OF CREDIT ANY DOCUMENT, BOND, PERMIT, INSTRUMENT, OR AGREEMENT OTHER THAN THE DRAFTS AND DRAWINGS STATEMENTS REQUIRED HEREUNDER.

THIS LETTER OF CREDIT IS GOVERNED BY DIVISION 5 OF THE PENNSYLVANIA UNIFORM COMMERCIAL CODE AND, WHERE NOT INCONSISTENT, THE UNIFORM CUSTOMS AND PRACTICE FOR DOCUMENTARY CREDITS (1993 REVISION, IN EFFECT AS OF JANUARY 1, 1994), INTERNATIONAL CHAMBER OF COMMERCE PUBLICATION NO. 500. DISPUTES ARISING UNDER THIS CREDIT SHALL BE GOVERNED FIRST BY THE LAWS OF THE COMMONWEALTH OF PENNSYLVANIA.
